1) Who we are (Controller)

2) What data we may collect

- Contact data: name, e-mail, WhatsApp number, and the message content submitted via the form.
- Browsing/technical data: technical logs (e.g., approximate IP, timestamp, device/browser type) and cookies/identifiers, when enabled.
- Compliance data (when applicable): information and documents required for KYC/AML checks, always proportionate and for a defined purpose.

3) Purposes

- Respond to inquiries, provide support and guidance regarding the P2P trading process.
- Prevent fraud, abuse and scam attempts, and protect our operation and users.
- Comply with applicable legal/regulatory obligations and internal compliance procedures (KYC/AML).
- Improve website experience, security and performance (e.g., essential cookies and preferences).

4) Legal bases

We process data under applicable legal bases (as permitted by law), such as: contract performance and pre-contractual steps, compliance with legal/regulatory obligations, legitimate interests (security and fraud prevention), and, where required, consent (e.g., non-essential cookies).

5) Data sharing

We do not sell personal data. We may share data with technology providers used to operate the website and handle communications, and with competent authorities where legally required.

6) International transfers

Some providers and CDNs may process data outside Brazil. In such cases, we adopt contractual and technical safeguards consistent with applicable data protection requirements.

7) Retention

We retain data for as long as necessary for the purposes described and to meet legal, audit and security requirements. After that, we delete or anonymize data when possible.

8) Data subject rights
